For the A and B sections, the case name is followed by the volume, issue and page number on which the case begins.

## Section C - Subject Matter Index

This section is organized alphabetically by major headings, and within each major heading by sub-topics. Topics are followed by references to the relevant case(s). Cases are cited to the issue and page number on which the case begins.
